## BARRETT CROSSING ADOPTION OF WORKING CAPITAL ASSESSMENT


Pursuant to Section 6.08 of that certain <u>Declaration of Covenants, Conditions and Restrictions for Barrett Crossing</u>, recorded under Document No. <u>RP-2023-296998</u>, Official Public Records of Harris County, Texas, as amended (collectively, the "Declaration"), CENTURY LAND HOLDINGS OF TEXAS, LLC, a Colorado limited liability company (the "Declarant") files this Adoption of Working Capital Assessment as follows:
