Dear New Customer:

**Welcome to the Montgomery County M.U.D. No. 110 Water District.** The following information is being provided to help you become familiar with the policies and procedures related to your sewer service.

Following are some of the costs associated with services provided by **Montgomery County M.U.D. No. 110**. To establish service with the District a \$75.00 security deposit is required. The District requires a non-refundable \$30.00 application fee be paid at the time of application for service. Please return the deposit and application fee along with the completed application for service. We will not be able to establish service in your name until all of these items are received in the office. Please call the office for your payment options. The deposit will be refunded following the due date of your final bill.

**Rates for Sewer Service**  
**\$55.00 Flat Rate**

The rates listed above are applicable at the time this letter is presented but are subject to change at any time.

Your due date is the 15<sup>TH</sup> of each month. A 10% penalty will be assessed if payment is received after the due date. This amount is shown in the "After Due Date" block on your bill.

If your account is 30 days past due at the time current bills are generated, a termination notice will be sent to your address. At this point a \$15.00 fee will be assessed to your account and all charges (including current charges) are due to avoid termination of your service. Should full payment not be received as directed on the letter, your service will be disconnected. Should service be disconnected, a \$200.00 fee will be added to your account. Full payment will be required to restore service, payable by money order or cashier's check only. A \$30.00 charge will be assessed on all checks returned by the bank.

**Montgomery County M.U.D. No. 110** has contracted Best Trash to provide trash collection services. If you have any questions about trash services, please call Best Trash customer service line.
